## COOKIE POLICY

This Cookie Policy is intended for those browsing/using [wisuno.com](https://wisuno.com) (hereinafter referred to as the "Site") owned and operated by **Wisuno Limited** and its affiliates and subsidiaries ("we" or "us") and describes and explains how we treat information that is received and/or collected, when received or collected, through your use of the Site.

### NECESSARY COOKIES

These cookies are necessary for the website to function and cannot be switched off in our systems. They are usually only set in response to actions made by you which amount to a request for services, such as setting your privacy preferences, logging in or filling in forms. You can configure your browser to block or alert you about these cookies, but certain areas of the site will not function properly. These cookies do not store any personal data.

### COOKIES

We may set cookies and related standard technologies (jointly: "cookies") as you visit the Site, use our online products and services or view our products and offers. We may also use Third-party cookies or allow third parties to set cookies.

A cookie is a small amount of data which is stored on your computer or device for the purpose of identifying the browser or product during interactions. We also use cookies to track the interest and usage patterns of our users so we can achieve our goals as set forth in the "How we use the information" section below.

You can configure your web browser not to accept cookies, although this may affect how you see and are able to use the Site and online products and services.

#### **Cookies are typically divided into four main types; we may use some or all:**

- Strictly necessary cookies. These are cookies that are required for the operation of a website.
- Performance cookies. These types of cookies allow providers to understand and analyze the key performance indexes of the website which helps in delivering a better user experience for the visitors.
- Analytical cookies. These cookies are used to understand how visitors interact with the website. These cookies help provide information on metrics, the number of visitors, bounce rate, traffic source, etc.
- Advertisement cookies. These cookies are used to provide visitors with relevant ads and marketing campaigns. These cookies track visitors across websites and collect information to provide customized ads.
- Functionality cookies. These are used to recognize users when they return to a website. They enable the personalization of content, the recognition of users and remember user preferences (for example, their choice of language or region).

### DISABLING AND DELETING COOKIES

- A User can choose to enable or disable cookies in their internet browser. Most internet browsers also enable a user to choose whether they wish to disable all cookies or only Third-party cookies.

By default, most internet browsers accept cookies, but this can be changed. For further details, please consult the help menu in your internet browser.

- A User can also choose to delete cookies at any time. This may, however, result in the loss of information that enables the Website to be accessed more quickly and efficiently including, but not limited to, personalized settings.
- Users are recommended that they ensure that their internet browser is up-to-date and to consult the help and guidance provided by the developer of that internet browser if unsure on how to adjust the privacy settings.

## **HOW WE USE THE INFORMATION**

Currently across our websites and trading platforms, we make use of cookies to help manage your visitor experience. This means that to use any of our websites and trading platforms, we require your consent to our cookie use, through which we may analyze the general visitor activity on the websites, manage your personal preferences, provide relevant or timely information to you or offer focused advertisements. In relation to the information we gain as part of a Communication we may use it to acknowledge your comments and/or reply to your questions and we may store it in case we need to correspond later. We will not use the contact details you provide us with for marketing messages without your consent.

Cookies set across our site and trading platforms, set by our 3rd party partners or us, can be in the form of session or persistent cookies, and may use different technologies, such as JavaScript or Flash.

If you would like to refuse the cookies set by our site and trading platforms, you can do this on a cookie-by-cookie basis subject to browser settings. You may limit the site operation or functions if you limit cookies.
